Block (Per Capita) Grants

Urbanized Program \$51,529,000

Rate for Allocations: \$1.56 per capita. To be eligible a county must have a population of 200,000 or more and a regional park district must be located in an urbanized area.

An "urbanized area" consists of a central city or cities and surrounding closely settled territory, as determined by the Department of Finance on the basis of the most recent verifiable census data. The most recent verifiable census data is the "Urbanized Areas" maps and detailed tables of census designated places that are urban or rural found in Summary File 1, 2 or 3 produced by the Bureau of the Census, an agency of the U.S. Department of Commerce. This information is based on the 2000 U.S. Census and is available from the U.S. Census website found at http://www.census.gov/ by following links to American Fact Finder.

Heavily Urbanized Program \$10,455,200

Rate for Allocations: \$0.44 per capita. To be eligible a county or regional park district must have a population of 1,000,000 or more.

Note: A county with no allocation is the result of an overlap with a regional park district that operates and manages park and recreational areas and facilities for that population.
