I. CALL TO ORDER

Legal notice having been duly given and a quorum present, the State Historical Resources Commission (Commission) meeting was called to order at 9:06 a.m. by Chair Bryan Brandes.

II. PLEDGE OF ALLEGIANCE

Chair Brandes led those assembled in the Pledge of Allegiance.

III. INTRODUCTION OF COMMISSIONERS AND STAFF

Chair Brandes welcomed all present, and asked the Commissioners to introduce themselves. Deputy State Historic Preservation Officer (Deputy SHPO) Jenan Saunders introduced herself and members of the OHP staff in attendance.

IV. WELCOME

The Honorable Paul W. Foster, Mayor of Redlands, and Donn Grenda, Vice President, Redlands Conservancy, welcomed the Commission and staff to the City of Redlands, speaking of the value of preservation, the City's history, and the commitment to preserving the community's collective heritage.

Deputy SHPO Saunders thanked the Redlands Conservancy, Redlands Area Historical Society, Redlands Historic and Scenic Preservation Commission, Donn and Janet Grenda, Larry Burgess, and Margie Armintrot, for each of their roles in hosting the previous day's workshop, tour, reception, and dinner for the Commissioners and staff.

Vice-Chair McKay moved to approve the minutes as presented. Commissioner Bertoli seconded the motion. **Action:** Motion carried unanimously by roll call vote.

VII. COMMISSION AND STAFF REPORTS

A. Chair's Report

No report given.

B. Executive Secretary's Report

Deputy SHPO Jenan Saunders presented the report on behalf of Executive Secretary and SHPO Julianne Polanco who was absent. Deputy SHPO Saunders reported that the Office of Historic Preservation (OHP) had applied for an underrepresented communities grant from the National Park Service (NPS) to begin development of a statewide context on Asian Americans and Pacific Islanders in California. The decision was made to not apply for the NPS African American Civil Rights grant due to a limited capacity to address two grants at the same time should we have received them both. Deputy SHPO Saunders also reported that the OHP, working with local governments and nonprofits, successfully met the goal set for their current underrepresented communities grant, which involved identifying and developing seven to ten National Register of Historic Places nominations for Latino-associated properties in California. Deputy SHPO Saunders noted that the OHP has started the public outreach phase to develop a new Statewide Historic Preservation Plan for California, covering the years 2018 through 2022. She mentioned the possibility of holding one of the State Plan public listening sessions at the Commission's February 2017 meeting. Finally, Deputy SHPO Saunders concluded the Executive Report with a brief slide presentation of the recipients of the 2016 Governor's Historic Preservation Awards. Deputy SHPO Jenan Saunders asked that due to the absence of SHPO Julianne Polanco and Commissioner Adrian Praetzellis from the current meeting, a discussion regarding the CHRIS be delayed until the Commission's February 2017 meeting. Deputy SHPO did report that the annual meeting of CHRIS Information Center Coordinators took place in late September and proved productive and successful. She also reported that the OHP is working on the update to the CHRIS inventory digitization assessment in order to better identify the resources needed to complete the digitization process. The goal is to have the assessment completed in time to report on it at the February commission meeting.
