I. CALL TO ORDER

Legal notice duly given and a quorum present, Chairperson Sriro called the State Historical Resources Commission (Commission) meeting to order at 9:04 a.m.

II. PLEDGE OF ALLEGIANCE

Chairperson Sriro led those assembled in the Pledge of Allegiance.

Chairperson Sriro modified the order of the meeting to allow Director Lisa Mangat to address the Commissioners first. Following Director Mangat's welcome, Chairperson Sriro announced two additional changes to the agenda: the Japanese Hospital nomination was moved from Consent Calendar II to Discussion and Action. The To-Kalon Vineyard nomination was removed from the agenda and will be heard at the November meeting so that the Office of Historic Preservation may have time to review a large amount of information recently received regarding the nomination.

The announcements were followed by the introduction of commissioners and staff, with the agenda then returning to the order as noticed.

Commissioner Moss moved to accept the nomination as presented, and direct the State Historic Preservation Officer to forward the nomination to the Keeper of the National Register of Historic Places for listing. Commissioner Adams seconded the motion. **Action:** Motion carried by roll call vote, 6-0-0, with one recusal.

2. Glen Park BART Station
San Francisco, San Francisco County
Local Level of Significance; Criterion C

With the public comment period concluded, Commissioners then entered into discussion regarding the Glen Park BART Station nomination. At the conclusion of the discussion period, Chairperson Sriro asked for a motion.

Commissioner Adams moved to accept the nomination with a period of significance 1968 to 1972, and direct the State Historic Preservation Officer to forward the nomination to the Keeper of the National Register of Historic Places for final listing. Commissioner Hoyos seconded the motion. **Action:** Motion carried by roll call vote, 6-0-1.

Chairperson Sriro updated the Commission on the California properties listed on the National Register of Historic Places since the last meeting of the Commission, and as noted in the meeting agenda.

XV. COMMISSION DISCUSSION AND ACTION ITEMS

A. California Historical Resources Information System (CHRIS) Fees (Action)

Anmarie Medin, CHRIS Coordinator, OHP, read into the record the staff report outlining CHRIS fee considerations. Commissioners then entered into further discussion regarding CHRIS fees.

Following discussion, Commissioner Brandes moved to extend the current CHRIS fee rates and structure until the first Commission meeting of 2020. Commissioner Adams seconded the motion. **Action:** Motion carried by roll call vote, 7-0-0.

B. CHRIS Tribal Historic Preservation Officer Access Policy (Action)

Deputy SHPO Jenan Saunders provided a report on THPO Access Policy considerations and status, and shared comments and questions submitted by tribes. SHPO Polanco expressed appreciation to all tribes that participated. Commissioners entered into discussion about the Access Policy.

Following discussion, Commissioner Hansen moved to accept the CHRIS Tribal Historic Preservation Officer Access Policy as proposed. Commissioner Moss seconded the motion. **Action:** Motion carried by roll call vote, 7-0-0.

C. Committees (Action)

Chairperson Sriro reported on the prior day's workshop discussion regarding Commission committees. Upon further discussion, commissioners agreed to continue the discussion at the Commission's next meeting and vote on possible action then.

XVI. COMMISSIONERS' COMMENTS

Chairperson Sriro expressed sorrow and condolence on the recent murder of Gaylen Lee, tribal elder of the North Fork Rancheria of Mono Indians.

SHPO Polanco noted the recent retirement of ACHP Chairman and former California SHPO Milford Wayne Donaldson, suggesting the Commission present him with a resolution at the spring 2020 meeting.
