Tour Information: The tour is open to the public and will begin at 8:30 a.m. at the Bureau of Land Management (BLM), Ukiah Field Office, 2550 North State Street, Ukiah, California. The tour group will travel to various locations within the BLM South Cow Mountain Recreation Management Area. The tour will last approximately seven to eight hours and may involve some walking over uneven terrain. Certain weather conditions may necessitate a change to the tour route (see Tour Agenda) or cancellation of the tour.

Seats in OHMVR vehicles will be extremely limited or not available on this tour. If you wish to tackle the tour in your own vehicle, a 4x4 or all-wheel drive vehicle is recommended. Layered clothing, sturdy footwear, hats or caps, and sunscreen are also recommended. Participants are encouraged to be prepared with enough food and water supplies for a full day on the trail. Cell phone service may be limited during the tour.

Following the conclusion of the tour, OHMVR Commission members may leave for a recreational ride. No business will be discussed and the public is invited to attend.
