NOTICE IS HEREBY GIVEN that the Off-Highway Motor Vehicle Recreation (OHMVR) Commission, pursuant to authority contained in Section 5090.24 of the Public Resources Code and Section 11120 et seq. of the Government Code, will conduct a tour on August 13-14, 2019, and meet on August 15, 2019 according to the following schedule.

OHMVR Commission Tuesday, August 13, 2019 through Overnight Tour: Wednesday, August 14, 2019

7:00 a.m. - Rubicon Trail, Loon Lake Trailhead

Tour Information: The tour is open to the public and will begin at 7:00 a.m. at the Loon Lake Trailhead kiosk / staging area on Tuesday, August 13, 2019. The tour group will travel to the historic Rubicon Springs campground where they will camp overnight, and then exit the Rubicon Trail in Tahoma, California the following day, Wednesday, August 14, 2019.

The tour group will stop at various locations on the Rubicon Trail throughout the twoday tour. The tour may involve some walking over uneven terrain. Tour participants are responsible for their own camping gear and personal items; however, storage space in tour vehicles is very limited.

Seats in State vehicles will not be available on this tour. If you wish to tackle the tour in your own vehicle, a high clearance 4x4 vehicle is required. Public participants are responsible for their own transportation, equipment repair, camping gear, and meals. Cell phone service will be limited during the tour.

Following the conclusion of the tour, OHMVR Commission members may leave for a recreational ride. No business will be discussed and the public is invited to attend.
