**Tour Information:** The tour is open to the public and will begin at 8:00 a.m. on Thursday, November 7, 2019, at the dirt parking lot adjacent to Fin's Seafood & Sports Bar located at 105-1 West Grand Avenue, Grover Beach, California 93433. The tour group will stop at various locations within the Oceano Dunes District and will last approximately 7 to 8 hours. Tour participants are responsible for their own food and water supplies, and should wear layered clothing, sturdy footwear and hats and bring sunscreen.

Seats in State vehicles will not be available on this tour. If you wish to tackle the tour in your own vehicle, a high clearance 4x4 vehicle capable of traveling on soft sand and dunes is recommended. Participants should also have experience driving in this environment. The Division will not be available to extricate stuck vehicles. Vehicles must display whips and flags in accordance with California Code of Regulations Title 14, Division 3, Chapter 6, Section 4609(a)(3). Vehicles without whips and flags will not be permitted on the tour.

Following the conclusion of the tour, OHMVR Commission members may leave for a recreational ride. No business will be discussed and the public is invited to attend.
