Basic Information: The tour is open to the public and will begin at 10:30 a.m. Commissioners and staff will meet the public at the Chappie-Shasta ORV Staging Area. The tour is expected to last approximately 4 hours. Weather permitting, the tour group will stop at various locations within the main staging area. **To access the tour location, individuals will be required to show proof of current vehicle registration and insurance to pass through the security checkpoint on the Shasta Dam.**
