Outreach and Education Updates by Joleen Ossello, State Park Interpreter I

2024 Report Summary

Interpretive Senior Park Aide position increased the number of events and projects. Highlights include participation in the first California State Parks Week and a focus on the Road & Trail Management Plan public outreach.

- Attended 15 in park promoter sponsored special events reaching 1778 visitors.
- Hosted 7 State Parks events reaching 843 visitors.
- Attended 5 off-site outreach events reaching 1266 visitors.
- Posted to social media at least four times per week. An all-time high Facebook reach of 32,886 occurred in November with 8,233 followers. In contrast, Instagrams 3,182 November reach with 4,509 followers.

- California State Parks Week in June "Explore and Discover Urban OHV Culture" event provided free off-highway vehicle safety lessons and tours of Prairie City SVRA in recreational off-highway vehicles (ROVs) and all-terrain vehicles (ATVs).
- Notable projects included, Eagle Scout RC Course, New Hangtown Banners, Micro-Dyce RC Competition, OHV Safety Week Art Installation
