PROJECT LOCATION: Mount San Jacinto State Park, Riverside County, CA

PROJECT DESCRIPTION: The Management Plan would: improve trails throughout Long Valley by aligning them away from sensitive resources as well as reconstructing them to improve accessibility; relocate visitor facilities away from Long Valley Creek; construct a new Adventure Center with restroom facilities, construct a multi-purpose outdoor activity area, rehabilitate and expand the ranger station; provide an informational kiosk for visitors entering Long Valley from the Palm Springs Aerial Tramway; construct a small equestrian staging area with corrals and water; replace and improve the concrete pathway from the Palms Springs Aerial Tramway Mountain Station to Long Valley including a funicular or electric cart for disabled access and medical transport.

The California Department of Parks and Recreation has approved this project on February 6, 2012, and has made the following determinations:
