- **Several privately owned parcels may be added to the site in the future, potentially increasing it up to 63 acres.**

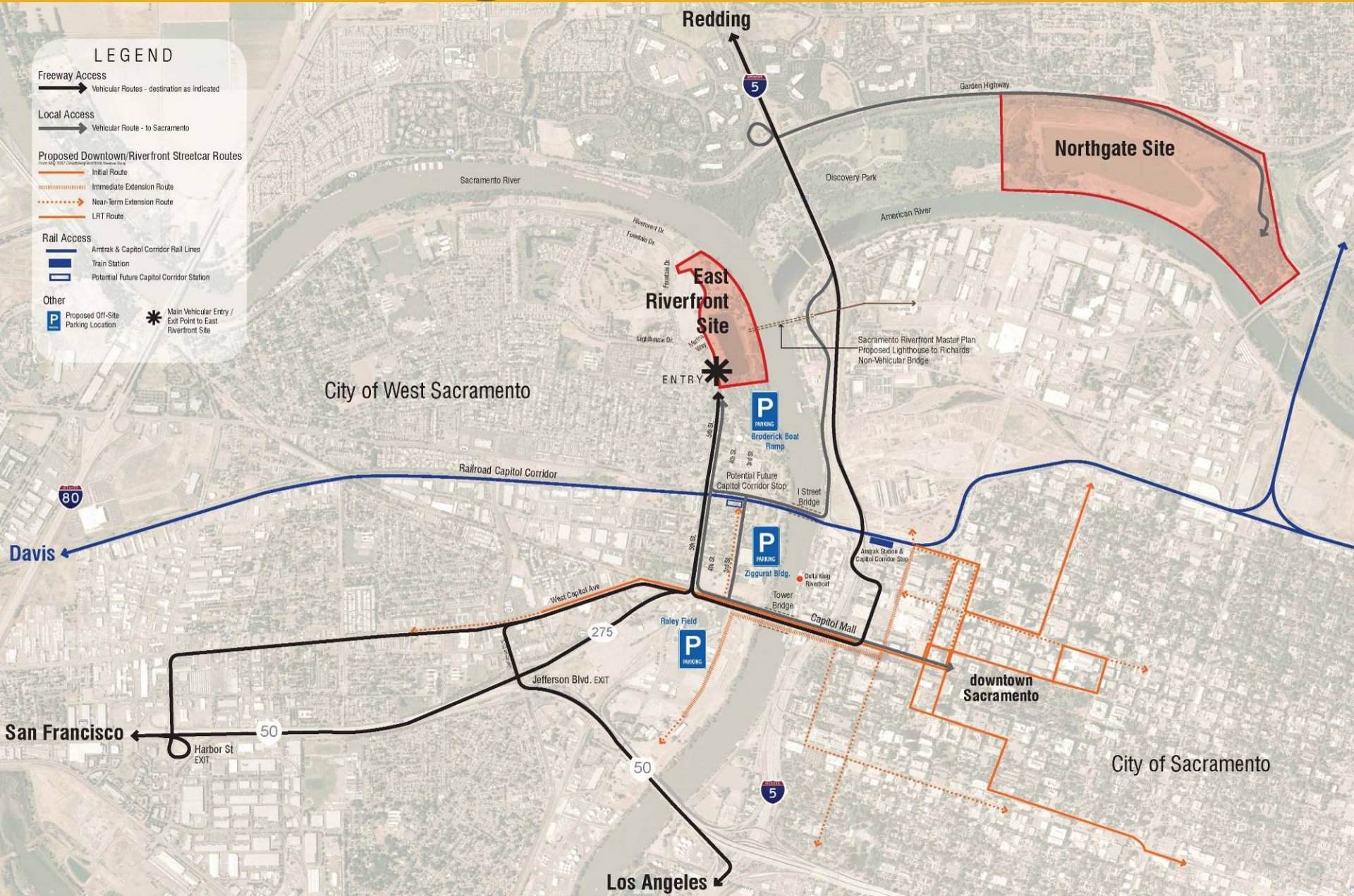
Master Plan Concepts

Limited Development/Natural Area

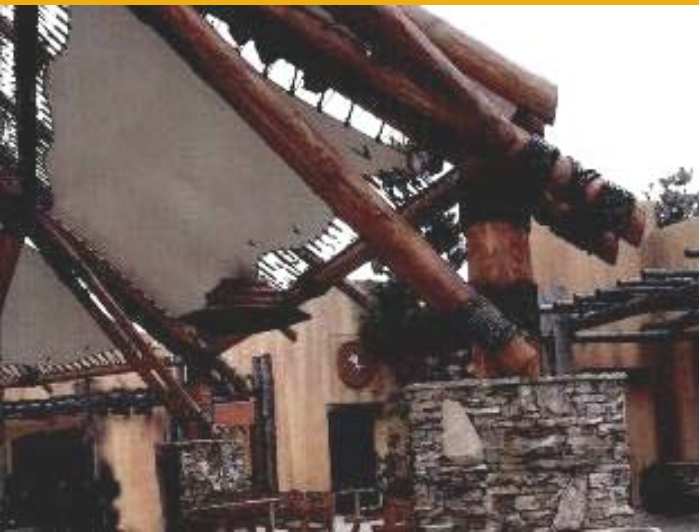
