Cuyamaca Rancho State Park General Plan and EIR Process & Timeline

Existing Conditions & Resources Inventory (COMPLETE)

Survey and data gathering of recreational, natural and cultural resources and visitor use information.
Summer 2012 – Spring 2013

General Plan Development & Three Public Meetings/Workshops

- 1st Public Meeting/Workshop - Introduce Planning Process, Present Resource Summaries, & Identify Public Issues. *Fall 2012 (COMPLETE)*
- Draft Vision Statement, Declaration of Purpose, Management Zones Matrix and Map Alternatives and Draft Potential Plan Proposals. *Fall 2012 – Summer 2013 (COMPLETE)*
- 2nd Public Meeting/Workshop - Present Management Zone Alternatives and Potential General Plan Proposals & Receive Public Input. *Spring 2013 (COMPLETE)*
- Development of Preferred Plan and Draft Goals & Guidelines. *Spring 2013 – Fall 2013 (COMPLETE)*
- 3rd Public Meeting - Present the Preferred Plan, Draft Goals & Guidelines & Receive Public Input. *Fall 2013 (TONIGHT)*
- Preliminary General Plan /Draft Environmental Impact Report available for a 45-day public review period (*Spring – Summer 2014*)

Issue Notice of Preparation and Initial Study for EIR

This is a legal notice and part of the CEQA process. The Notice of Preparation (NOP) and Initial Study were issued and listed on the General Plan webpage on April 9, 2013. The NOP was reviewed by interested agencies and the public. An NOP comment period for responsible agencies was provided for 30 days beginning April 9, 2013 and ending May 9, 2013. **(COMPLETE)**

Issue Preliminary General Plan/Draft EIR for Public Comment

The document will be placed on the California State Parks website under “CEQA Notices” and on the General Plan Website. There will be a 45-day CEQA-required public review period to receive public comment which must contain a contact name and address to be considered part of the public record.
(Spring – Summer 2014)

Prepare Preliminary GP/Final EIR

Develop Staff Responses to Public Comments and make any changes to the General Plan/EIR based on public comment, agency comment, and/or Department review and post on the General Plan website.
(Summer 2014)

State Park & Recreation Commission Hearing

Will be held in San Diego and have a public comment period prior to adoption of the General Plan/EIR. Commission recommendations/modifications may be included in the General Plan/EIR.
(Fall 2014)

Final General Plan/EIR

Change the Final EIR as appropriate & Certify.
Official immediately if adopted by the Commission. Make the Final version available via the internet as well as in printed form.
