## California State Parks Announces a Concession Opportunity at Huntington State Beach

*HUNTINGTON BEACH, Calif.* – California State Parks is accepting proposals for a five-year concession contract, with the option to extend the term an additional five-years, to operate beach stands and provide equipment rentals and catering services at Huntington State Beach. A pre-proposal meeting to operate the concession is set for July 25 at 6 p.m. at the Orange Coast District Office in Huntington Beach. A tour of the concession facilities and premises will be available prior to the meeting from 4:45 to 5:30 p.m.

Huntington State Beach is located within the city limits of Huntington Beach. The beach extends from Beach Boulevard southerly along the coast to the Santa Ana River, a distance of 11,000 feet. The park has four entrance gates, typically located adjacent and up coast of the concession stands. The Magnolia entrance is open year-round while the other entrances are opened and staffed depending on the time of year, weather and funding availability.

Some enroute camping may be permitted from time to time. However, the beach is predominantly for day use and has several fire-rings. Visitation is highest from May to September of each year and is directly dependent upon weather conditions.
