**Tour Information:** The tour is open to the public and will begin at approximately 9:00am on Wednesday, March 06, 2024 at Big Basin Redwoods State Park, Saddle Mountain location. Fees will be waived upon entry for members of the public participating in the tour. Members of the public will be expected to drive their own vehicle to the different locations on the tour. The roads are paved winding narrow mountain roads. To be a part of the tour, participants must be present when the tour begins.

The tour is expected to last approximately 5-6 hours. Lunch is expected to occur at approximately 12:00pm and tour participants are responsible for bringing their own food, water, and supplies. Participants should also consider wearing appropriate clothing and footwear suitable for the walking portion of the tour. Comfortable hiking boots or running shoes, jackets, and hats are recommended.
