



SUE-MEG STATE PARK

WELCOME! Sue-meg (pronounced “soo-may”) State Park sits on a lushly forested promontory beside the Pacific Ocean. The 1-square-mile park is densely packed with potential adventures. On a short walk around the perimeter of the park, you can hunt for agates, explore tide pools, and walk through a temperate rainforest filled with native shrubs and trees, as you peer out at seals, sea lions, and migrating whales. In the park’s interior, you will find a visitor center, a native plant garden, and a reconstructed Yurok plank house village. Deepen your learning about the people and place here by joining one of our guided hikes or activities in the summertime. You do not have to go far to find something fascinating at Sue-meg State Park.

PLEASE REMEMBER

Sumêg Village—Respect and protect these culturally significant buildings and structures. Climbing the structures is prohibited.

Pets—Except for service animals, dogs are not permitted on the beaches or park trails. Dogs are allowed in campgrounds, picnic areas, and along paved roads.

Coastal Hazards—Swimming is not advised. The ocean off Sue-meg State Park is cold and dangerous. Be cautious of “sneaker wave” activity. Sue-meg State Park is located in a tsunami zone.

Check the Tides—Check current tide tables to avoid being trapped by high tides. When visiting tide pools, make safety a priority and practice tide pool etiquette.

Whale Watching

Migrating and resident gray whales can be spotted throughout the year. Southern migration is from December to January; northern migration is from March to May.

ACTIVITIES

Hiking—The Rim Trail (2 miles) offers excellent views of the ocean and offshore rocks. Between Agate Beach and Palmer's Point, four rather steep quarter-mile trails connect the Rim Trail to the shore.

Tide Pools—Explore the rich biodiversity of one of the harshest environments on Earth, where ocean meets land.

Agate Hunting—Explore the complex geology of the Northern California coastline by rock hounding in the wave action zone! A limit of 15 pounds per person, per day can be collected.

Camping—Make a reservation through ReserveCalifornia.com or walk-ups can register at the kiosk. Car camping: Penn Creek, Abalone, Agate Beach. Cabins: Agate Beach. Group campgrounds: Beach Creek, Lookout Rock, Red Alder. Hike and bike campground: Sue-meg.

SPECIAL EVENT PERMITS

Special event permits are required for any activity that is outside of regular park use. Activities that require a permit may include:

- Marathons, bicycling events, equestrian events, and any other organized competition.
- Events using catering companies.
- Any event involving the sale of any items, including food.
- Any events where tickets are sold or fees are charged for participants.
