



GRIZZLY CREEK REDWOODS STATE PARK

WELCOME! Tucked away along the Van Duzen River on Highway 36, Grizzly Creek Redwoods State Park offers a redwood forest full of big trees and few people. Established in 1943, this park is a family favorite where you can explore a few miles of trails, including Cheatham Grove, an American With Disabilities Act (ADA)-accessible trail. Kids can safely ride bikes around the 28-site paved campground loop, and campers can gather for Junior Ranger programs and campfire programs. The visitor center offers unique mementos and the opportunity to view taxidermic bears, mountain lions, and moles, along with other displays.

THINGS TO DO

If you have an hour, walk the 0.7-mile loop through Cheatham Grove. Cheatham Grove is accessed at milepost 13.0 on Highway 36.

If you have half a day, walk through Cheatham Grove and learn about park wildlife and history at the visitor center. Have lunch beside the Van Duzen River.

If you have a full day, take a hike on one of the trails. In the summer, have a barbecue picnic, join a park-led program, and take a swim in the Van Duzen River; follow swimming safety tips (parks.ca.gov/?page_id=30044), including wearing a life jacket.

ACTIVITIES

Camping—Register in-person at the campground or make reservations on ReserveCalifornia.com, reservations are recommended as campground is usually full. There is one small car campground open only during the summer and located adjacent to Highway 36.

Park-Led Activities—During the summer season, interpretive activities such as nature walks, Junior Ranger programs, and campfire programs are held weekly.

Fishing—Catch-and-release fishing using barbless hooks is allowed in the fall through spring. A fishing license is required. Salmon and steelhead run in the fall and winter. Low water flow usually closes fishing in the summer.

PLEASE REMEMBER

Wildlife—Do not feed wildlife. The park is in bear country; properly store all food and scented items in the bear-resistant lockers.

Campfires—Fires are permitted only in the stoves or fire rings provided by the park.

Pets—Dogs must be on a leash no more than 6 feet long and must be confined to a tent or vehicle at night. Except for service animals, pets are not allowed on trails.
