The largest of the state parks at Lake Tahoe, Ed Z'berg Sugar Pine Point State Park is 2,000 acres of dense pine, fir, aspen, and cedar forests set behind nearly 2 miles of lake frontage.

PARK FEES are due and payable upon entry into the park. Use the self-registration system if the entrance station is closed. Fees include one vehicle. Extra vehicles will be charged a fee, with a maximum of three vehicles.

OCCUPANCY: Please visit ReserveCalifornia.com for occupancy recommendations.

VEHICLE PARKING: Vehicles may only be parked in your assigned campsite. They must remain on the pavement and not extend into the roadway beyond the campsite number or limit line. You may park two vehicles in each campsite. Additional vehicles must be parked in the overflow parking lot next to the campfire center.

CAMPsites: Ropes or lines may not be attached to any plant, fence, or park structure. You may attach lines to your own property. It is essential that tents and other equipment be confined to the space assigned. For information on the campsite limits, please ask a ranger or the camp host.

CHECK-OUT TIME is noon. Please vacate your site by that time. Check-in time is 2 p.m.

SPEED LIMIT: The maximum speed limit is 15 mph. When pedestrians are present, even 15 mph might be too fast. Use good judgment.

DOGS must be kept on a leash no longer than 6 feet and under human control at all times. They are allowed only on paved roads or in your campsite. Except for service dogs, dogs are not permitted on fire roads, trails, or beaches. Dogs must be confined to a vehicle or tent at night. Please clean up after your pets.

BEARS commonly explore campgrounds in the Lake Tahoe Basin looking for food. Metal bear-resistant lockers are provided in each campsite.

FOOD LOCKERS: All food, beverages, and toiletries are required by law to be stored in provided food lockers, unless being consumed or prepared for consumption. The inside dimensions of the food lockers are 36-inches deep, 43-inches wide, and 22-inches high. **Any food left out while not being consumed or prepared WILL result in a citation [California Code of Regulations Title 14, Section 4323(b)].**

QUIET HOURS are from 10 p.m. to 6 a.m. Radios, voices, and any sound-producing devices must not be audible beyond your immediate campsite. To ensure an enjoyable experience for everyone, please do not disturb other campers, regardless of the time of day or night.

GENERATORS may only be operated between the hours of 10 a.m. and 8 p.m.

ALCOHOL and glass containers are not allowed beyond your campsite.

FIRES/FIREWOOD: Fires are only allowed in fire rings provided. Collecting dead or downed wood is prohibited. Firewood is available for sale at the entrance station. All fireworks are prohibited.

DOWNED WOOD is a natural part of the forest floor. Please do not gather downed wood. Leaving it in place promotes native plant growth, animal habitat, and nutrient-rich soil.

BICYCLES are allowed only on paved roads. Bicycle riders under age 18 must wear a helmet. Bicycles ridden after dark must have a light. **Please ride safely.**

DAY USE at the park offers access to the beach, restrooms, changing rooms, picnic tables, trails, historic mansion, and visitor center. Day-use area is open from sunrise to sunset.

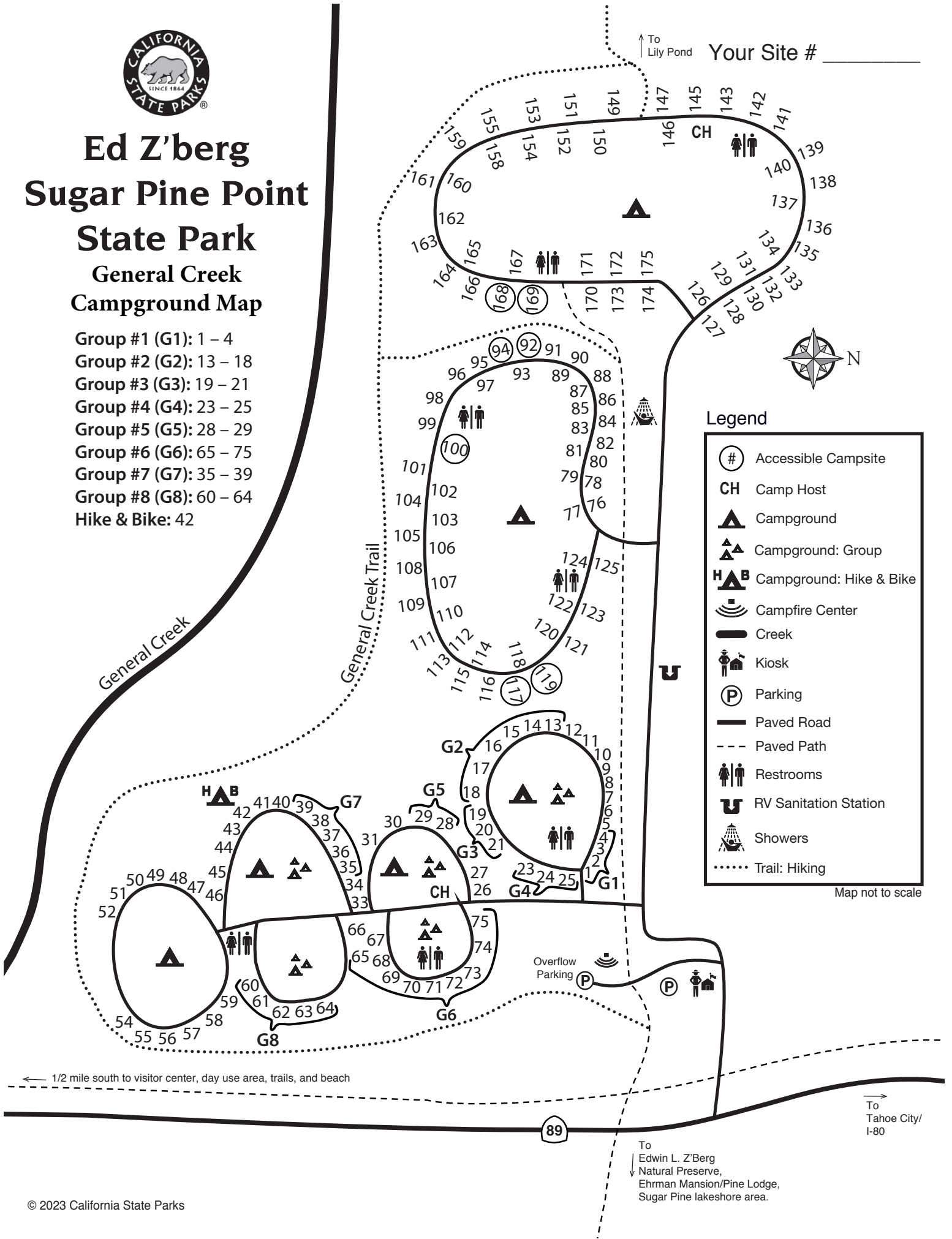
