These aquatic activities have inherent risks. Please read, sign, and date the release of liability, expect to get wet, and we suggest you bring a swim suit, clothes, or wetsuit suitable for swimming. Please wear sunscreen and a hat. Participants must be able to enter and exit the vessel unassisted and be capable of paddling on the water for two miles.

****Youth under the age of 18 must have this waiver completed and signed by a parent or guardian before participating in these activities.**

RELEASE OF LIABILITY

This release is intended to discharge in advance the State of California Department of Parks and Recreation, its Districts and/or any of their agents, servants, or employees by reason of any accident, death, injury, or damage to persons or property which I may suffer, from and against any and all liability arising or of a connected in a way with my participation in the State of California Department of Parks and Recreation program and/or activity, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.
