

Rules & Regulations for Doheny State Beach Group Picnics

Picnic Areas: A and B - All Reservation Fees are Per Day and are Non-Refundable

1. The group size requirement is 150 comfortably and up to 400 in B and 500 in A.
2. **Area A** has 30 picnic tables & three shade canopies; **Area B** has 20 picnic tables & 2 shade canopies.
2. Each area has one large fire ring, one large B.B.Q. grill, sinks, counters, cold drink bin, and electrical outlets (15-20 amps).
3. **Surrounding grass areas are not included in the reservation and cannot be used for event set up/activity.**
4. A Certificate of Insurance and Separate Endorsement will be required when reserving these areas. See page 2 of the Reservation Form.

June 1 to September 30

Area A: \$550.00 (Monday – Thursday)
Area B: \$450.00 (Monday – Thursday)
Area A: \$1000.00 (Friday)
Area B: \$800.00 (Friday)
Area A: \$1,500.00 (Saturday - Sunday)
Area B: \$1150.00 (Saturday – Sunday)

October 1 to May 31

Area A: \$550.00 (Monday – Thursday)
Area B: \$450.00 (Monday – Thursday)
Area A: \$675.00 (Friday)
Area B: \$575.00 (Friday)
Area A: \$950.00 (Saturday - Sunday)
Area B: \$750.00 (Saturday – Sunday)

Areas 1 - 4 (shade structure provided) (alcohol allowed with an approved permit/fee only).

1. The group size requirement is 40-50 comfortably and up to 100 maximum people per area.
2. Each area has 6 picnic tables, 1 large fire ring, 4 pedestal B.B.Q.'s and **a shade structure** - all on concrete pads.
3. **Surrounding grass areas are not included in the reservation and cannot be used for event set up/activity.**

June 1 to September 30

\$300.00 per area (Monday-Thursday)
\$325.00 per area (Fridays)
\$400.00 per area (Saturday and Sunday)

October 1 to May 31

\$250.00 per area (Monday-Thursday)
\$275.00 per area (Fridays)
\$350.00 per area (Saturday and Sunday)

Areas 7-13 (No alcohol permitted in these areas, no shade structure is provided).

1. The group size requirement is 40-50 comfortably and up to 100 people maximum per area. **NO ALCOHOL IS PERMITTED IN THESE AREAS.**
2. Each area has six picnic tables, 1 large fire ring; four pedestal B.B.Q.'s - all on concrete pads.
3. **Surrounding grass areas are not included in the reservation and cannot be used for event set up/activity.**

June 1 to September 30

\$250.00 per area (Monday-Thursday)
\$275.00 per area (Fridays)
\$325.00 per area (Saturday and Sunday)

October 1 to May 31

\$150.00 per area (Monday-Thursday)
\$225.00 per area (Fridays)
\$275.00 per area (Saturday and Sunday)

Areas 5 and 6 (No alcohol permitted in these areas).

1. The group size requirement is **no more than 25 people per area**. Areas 5 and 6 are intended for single families/small groups of 25 or less only.
 2. Each area has four picnic tables and two pedestal B.B.Q.'s - all on concrete pads. **No Fire Ring is provided.** Portable fire pits are not permitted.
- Grass areas are not included in the reservation and cannot be used for event set up/activity.

Area 5 - \$75.00 (Mon. - Thurs.) **\$175.00 (Fri., Sat., Sun.)** **NO ALCOHOL IS PERMITTED IN THIS SITE.**
Area 6 - \$150.00 (Mon. - Thurs.) **\$250.00 (Fri., Sat., Sun.)** **NO ALCOHOL IS PERMITTED IN THIS SITE.**

Food, Alcohol and Entertainment Regulations (Beer and Wine only)

Alcohol may be consumed at sites **A and B**, and sites **1 through 4** with the completion of an **Alcohol Waiver Form** that is available through the Doheny State Beach Permit Coordinator. The **non-refundable** alcohol waiver fees are: **\$250.00** for sites 1 through 4, **\$500.00** for sites A and B. Food and/or beverages cannot be sold to members of your group or to the public. For catered events, **ONLY Guest Services/Doho Café** can be used for food/beverage services, this includes alcohol service. No other food/beverage service/vendors are permitted. No deliveries or pick ups are allowed.

All other outside (non-food and beverage) vendors/services and all entertainment will not be permitted at this current time. No vehicles are permitted on sidewalks or in picnic areas for loading or unloading food and supplies. Violations of these and any park policy will result in citation and eviction of the group/event. Amplified sound is **not** permitted, this includes public address systems and bullhorns. No Karaoke. All games and activities require pre-approval.

PARKING INFORMATION AND FEES

Group reservations do not include or guarantee parking (or entry when the park is full). All parking is on a "first-come, first-served basis". There is no option for pre-payment of parking fees. **Warning: peak season weekends, holidays and special events, parking lots can fill as early as 10am.**

PARKING FEES:

- **\$15.00-\$20.00** per vehicle for all day, 6am to 10pm. Subject to vary during large special events. All day parking can be purchased through the QR codes provided in the park.
- Hourly parking is available for standard vehicles through the QR code application. **Oversized vehicles and buses are not eligible for hourly parking and must pay the all day fee. No drop-offs are permitted for buses.**
- **\$50.00** - per bus* (10 - 24 passengers)
- **\$100.00** - per bus* (25 or more passengers) Buses must pay fees upon entry to the park. No drop offs are permitted.

Information for Making a Reservation:

Reservations can be made 2 weeks and up to 6 months in advance of the event date. **An area is not reserved/confirmed until the Picnic and Special Events Permit Coordinator receives the completed required reservation forms and fees.** Reservations may be made in person or mailed to **Doheny State Beach**, located at 25300 Dana Point Harbor Drive, Dana Point, CA 92629. Attn. to Denise Estrada.

Office is open 10:00a.m.–3:00p.m. or later, **most** Mondays-Fridays. Appointments are advised. **All fees are non-refundable and non-transferable.** A \$50.00 processing fee will be charged when requesting a change in date and/or site once the reservation has been made. Requests for transfers of date or site must be made **two weeks prior to the reserved picnic date. The request must be in writing/email.** No reservations are accepted for Memorial Day, July 4th and Labor Day. The Doheny State Beach's picnic reservation email is doheny.events@parks.ca.gov. Picnic reservation requests by **FAX and e-mail will not be accepted.** We accept checks(made out to State of California) and credit card payments by appointment and in person, **Master Card, Visa and Discover only.** No cash is accepted.
