# State of California Department of Parks and Recreation San Diego Coast District Torrey Pines State Beach

ORDER NO. 935-631-001

May 23, 2024

# The following lands and facilities of Torrey Pines State Beach, San Diego Coast District of the Department of Parks and Recreation are hereby subject to the following provisions:

- A closure shall be in effect for all public use, entry or occupancy from 2300 hours to 0600 hours daily. [CCR 4326 (a), CCR 4358]
   Exception:
  - a. The parking areas and restroom facilities are closed to the public from sunset to 0700 hours daily.
- 2. All vehicles must be parked in parking lots on the pavement and within the marked lines of a single parking space. [CCR 4358]
  - a. Oversized vehicles are not permitted in the parking lot known as Torrey Pines State Beach South Lot.
    - Oversized vehicles are permitted in the parking lot known as Torrey Pines State Beach North Lot and must visibly display a valid California State Parks Oversize Pass sticker and Annual Day Use Pass or pay subsequent day use fees established for oversized vehicles.
  - b. Maximum of 8 oversized vehicles will be allowed within the parking lot known as Torrey Pines State Beach North Lot. All oversized vehicles must be parked within the designated spaces for such vehicles.
- 3. No animals may be brought into Torrey Pines State Beach. [CCR 4312 (f) (1) & CCR 4312 (f) (2)]

#### Exception:

- a. This section does not apply to "Seeing Eye", "Signal" or "Service" dogs. "Emotional Support" and "Comfort" animals are prohibited.
- 4. The consumption of alcoholic beverages is prohibited. [CCR 4326 (a)] <u>Exception:</u>
  - a. Special Event Permits with indication of alcohol distribution, possession, or consumption may be permitted in limited and designated areas and only when the permittee has demonstrated ability to regulate distribution, possession or consumption of alcoholic beverages.
- 5. All glass containers are prohibited. [CCR 4333]
- 6. All persons must stay off the coastal cliff bluffs and maintain a minimum distance of 10' for setting up any recreational equipment. [CCR 4307 & CCR 4326 (a)]

- 7. No unauthorized person shall be present on a lifeguard tower at any time. [CCR 4319]
- 8. All fires are prohibited. "Fire" is defined as the burning of any substance including but not limited to: wood, wood pallets, kerosene, oil, chemically treated wood, charcoal briquettes, fire logs, coffee based logs, fire starters, newspaper, books, and trees. [CCR 4311 (a)] *Exception:* 
  - a. The use of charcoal or propane stoves is permitted on the beach if the stove is self-standing and has a minimum clearance of 6" between the ground and bottom of the stove. Coals and ashes must be disposed of properly in a "Hot Coals" container or removed from the unit. Wood fires are prohibited.
- 9. Scavenging in trash and recycling bins is prohibited [CCR 4310, PRC 5003]
  - a. No person shall import or export any litter, domestic, agricultural, or commercial garbage or refuse, for the express purpose of disposing of such material in the State Park trash cans or dumpsters.
  - b. No person shall climb on or into trash containers, dumpsters, nor remove, separate, or dislodge the contents inside in total or in part.
  - c. No person shall place petroleum waste products, batteries or toxic substances in trash containers/dumpsters.
  - d. No person shall place ignited or smoldering materials or coals inside any trash container/dumpster.
- 10. Vehicle maintenance, service, repair or modifications are prohibited. No vehicle may be left standing or parked within the park unit for the purpose of maintenance, service, repair, modifications or similar operation except in an emergency. This prohibition includes changing oil, greasing, engine repair, drivetrain repair, brake repair, painting, etc. as well as washing or polishing a vehicle.

# Exception:

- a. An owner or operator of a vehicle or a mechanic may service or repair any vehicle which is temporarily disabled due to the extent that it is impossible to avoid stopping the vehicle within the park unit. Necessary repairs may be made to enable the vehicle to be safely moved or removed from the park so it can be fully repaired at a later time.
- 11. Feeding of wild and/or feral animals is prohibited. [CCR 4305 (e)]
- 12. No person shall launch or beach a vessel or weigh anchor or cast off. [CCR 4657] <u>Exception:</u>
  - a. Manually-propelled vessels, such as rafts and kayaks, stand up paddleboards, surfboards, and kite boards are allowed, except in areas where surf-riding is prohibited. Nothing in this exception allows vessels to be launched or used in Los Peñasquitos Marsh Natural Preserve.
- 13. Surf-riding is prohibited where designated by signs/flags. [CCR 4654]
- 14. Rock hounding is permitted within the wave action zone. [CCR 4301 (v), CCR 4611] Refer to CCR 4611 for conditions

- 15. The Department may close all or portions of Department land, including campsites, parking lots, roadways, day use areas, buildings, and/or beach, to visitors entirely, seasonally, or to specific activities or uses, or may limit the number of visitors entering an area, due to Special Events, maintenance, resource management activities, or natural occurrences, in order to protect resources, remove hazards, and/or ensure public safety. During such closures, all persons, vehicles, bicycles and other transportation implements shall not enter or remain therein. [CCR 4326 (a)]
- 16. "Tailgating" is prohibited in all parking lots. No awnings or slide outs may be erected or utilized. No chairs, tables, barbeques or other recreational equipment may be used in parking lots. [CCR 4323 (a)]
- 17. Parking spaces marked as AUTHORIZED VEHICLES ONLY either through signage, curb markings, and/or pavement markings are reserved for marked DPR vehicles or privately owned employee vehicles displaying a current employee vehicle parking pass. All other vehicles may be cited under VC 21113(a).
- 18. No aircraft are permitted east of the coastal bluff or north of the area known as Flatrock. [CCR 4304]
- 19. No person shall launch, land, or operate a powered unmanned vehicle or aircraft, Unmanned Aircraft Systems (UAS) [drone], or other remote controlled aerial device.
  <u>Exception:</u>
  - a. Commercial filming with applicable FAA Certification of Authorization (COA), appropriate park unit permits, and California Film Commission approval, and the following restrictions: (1) Filming season Sept 1- Feb 1; (2) no low flights; (3) No hovering over, near or by Peregrine Roosts or Eyries; (3) Purpose of request must be to promote State Parks or specifically Torrey Pines State Natural Reserve and Torrey Pines State Beach; (4) State Park Film monitor must be on site.
  - b. Scientific research with appropriate FAA registration and park unit permits.
  - c. Use by law enforcement under exigent circumstances with direct permission of the District Superintendent.
- 20. The following groups will be subject to Special Event and/or Concession permitting [CCR 4300] and are prohibited from utilizing state lands without first acquiring the required permit.
  - a. Any group categorized by CCR 4301(j)
  - b. Any group in excess of 25 persons
  - c. Any organized group using state lands for their meeting place.
  - d. Any persons filming or photographing state lands for monetary gain.
  - e. Any persons meeting on state lands for the express purpose of training or teaching others.

- 21. Authorized emergency personnel and vehicles as defined by Section 165 of the California Vehicle Code are exempt from this Order. Department of Parks and Recreation personnel, vehicles and equipment are also exempt from this order.
- 22. Exemptions to any of the above may be granted under a Special Event Permit and/or by the District Superintendent or designee, San Diego Coast District, 4477 Pacific Highway, San Diego, CA 92110.
- 23. Nothing herein shall affect any existing private, contractual, or property rights.
- 24. Nothing herein shall be construed in derogation of other provisions of law.
