Swim & Surf Areas

1. Effective immediately, when designated by a Departmental "Swim-Surf" sign, no person shall surf in the area designated for swimming, and no person shall swim in the area designated for surfing, at the following park units:

Gaviota SP, Refugio SB, El Capitan SB, Carpinteria SB, Emma Wood SB, San Buenaventura SB, or McGrath SB.

- 2. "Surfing" means using or attempting to use, whether riding or not riding waves, any floatation device:
 - A. Made of any rigid material or substance;
 - B. With "Skegs" or "Fins" attached;
 - C. Longer than forty-five (45) inches;
 - D. Shorter than forty-five (45) inches with two swim fins.
- 3. Exceptions to this order are hereby granted to Department employees, and participants in the "Junior Lifeguard" program, for education, training, patrol, or emergency purposes.
- 4. Exceptions to this closure order may be granted in writing by the District Superintendent, Channel Coast District, 911 San Pedro Street, Ventura, CA 93001.
- 5. Nothing herein shall affect any existing private contract or property rights.
- 6. Nothing herein shall be construed in derogation of other provisions of law.
