DISTRICT SUPERINTENDENT'S ORDER No. 910-05-07

CARPINTERIA STATE BEACH AND EMMA WOOD STATE BEACH-
VENTURA RIVER GROUP CAMP- DAY USE AREAS

Alcohol Closure

1. Effective immediately, to provide for the security, safeguarding, and preservation of resources, those portions of **Carpinteria State Beach, and Emma Wood State Beach-Ventura River Group Camp** commonly referred to as the **"Day Use Area"** are hereby declared a prohibited area for the consumption of alcoholic beverages. The areas closed by this order are limited to:

- A. The area within Carpinteria State Beach, bordered by Linden Avenue on the west, the mean high tide line on the south, Palm Avenue on the east, and the Union Pacific Railroad on the north, **not including Anacapa campground or Enroute campers.**
- B. The area within Emma Wood State Beach-Ventura River Group Camp, bordered by the Omer Rains Bike Path, (Including all portions of the bike path,) on the east, Highway 101 on the north, the North Beach Campground boundary on the west, and the high tide line on the south, **not including the camping areas.**

See attached maps for the areas described above.

2. Exception to this closure may be granted in writing by the District Superintendent, Channel Coast District, 911 San Pedro Street, Ventura, CA 93001.
3. Nothing in this order shall affect any existing private contract or property rights.
4. Nothing herein shall be construed in derogation of other provisions of law.
