# **DISTRICT SUPERINTENDENT'S ORDER No. 910-10-05**

### EMMA WOOD STATE BEACH (GROUP CAMP)

### En Route Camping

- 1. Effective immediately, the following conditions shall apply to en route camping facilities located at Emma Wood State Beach (Group Camp):
  - The maximum stay limit for use of the park's en route camping is fifteen hours; between the hours of 6:00 PM and 9:00 AM the following day, or one night's stay. All vehicles and equipment shall be removed prior to the 9:00 AM check-out time. All camping fees apply and shall be paid prior to occupying en route camping.
  - En route camping is intended as a limited option for first-time visitors who are traveling and no available campsites are available to them and/or their recreational vehicle. Only self-contained recreational vehicles are permitted to stay overnight in the en route camping area. All portions of the vehicle, including slide-outs and awnings may not extend beyond the physical or marked parking space. No fires, barbeques or outdoor recreational equipment is allowed in the en route area or adjacent to the en route camping area. During regular day use hours, use of the park's picnic area is permitted.
  - On the basis of space available, only those campers that have physically vacated the park for a minimum of 48 hours shall be considered for additional en route camping registration. The maximum occupancy by the same persons and/or equipment is limited to a total of ten (10) days in any calendar year.
- 2. Exceptions to this order may be granted in writing by the District Superintendent, Channel Coast District, 911 San Pedro Street, Ventura, CA 93001. Or, by the ranking State Park Peace Officer on duty.
- 3. Nothing in this order shall affect private contract or property rights.
- 4. Nothing herein shall be construed in derogation of other provisions of law.
