



DISTRICT SUPERINTENDENT'S ORDER No. 910-10-06

CARPINTERIA STATE BEACH, EL CAPITAN STATE BEACH, EMMA WOOD STATE BEACH,
GAVIOTA STATE PARK, MANDALAY STATE BEACH, MCGRATH STATE BEACH, REFUGIO
STATE BEACH, AND SAN BUENAVENTURA STATE BEACH

Vessel Launching

1. Effective immediately, no person shall launch, beach, weigh anchor (within 1000 feet of the high tide line), or cast off any vessel at **Mandalay State Beach, McGrath State Beach, or El Capitan State Beach**.
2. Effective immediately, no person shall launch, beach, weigh anchor (within 1000 feet of the high tide line), or cast off any vessel at **Carpinteria State Beach, San Buenaventura State Beach, or El Capitan State Beach** except vessels propelled solely by oars or paddles. Such vessels may only launch/beach at **Carpinteria State Beach** in the defined area around Carpinteria Lifeguard Headquarters of June 15 – September 10, and at the discretion of Peace Officers or Lifeguards.
3. Effective immediately, no person shall launch, beach, weigh anchor (within 1000 feet of the high tide line,) or cast off any vessel at **Emma Wood State Beach, or El Capitan State Beach** except vessels propelled solely by oars or paddles and vessels eight feet or less propelled solely by sail.
4. Effective immediately, no person shall launch, beach, or cast off any vessel at, **Gaviota State Park, or Refugio State Beach**, except vessels that can be launched and/or removed from the beach by hand. The only exception herein is the **Gaviota State Park Pier**, when the hoist is operational.
5. Exception to this order is hereby granted to **State Park Peace Officers** and **Mutual Aid Agencies** involved in training, when written approval is obtained in advance from the District Superintendent or his/her designee.
6. Authority is hereby granted to State Park Peace Officers, and Seasonal Lifeguards, (I & II) to supersede this order and prohibit the launching/landing of vessels when environmental conditions, crowds or Safety conditions would, in their judgment, constitute a hazard.
7. Exceptions to this closure order may be granted in writing by the District Superintendent, Channel Coast District, 911 San Pedro Street, Ventura, CA 93001.
8. Nothing herein shall affect any existing private contract or property rights.
9. Nothing herein shall be construed in derogation of other provisions of law.


